## From the **President's Desk.....**

The Hon'ble Prime Minister Narendra Modi on 08 November 2022 unveiled logo, theme and website of India's G20 presidency at Delhi. India will chair the G20 from December 2022. This is a momentous occasion as the G20 presidency offers India an opportunity to contribute to the global agenda. India is set to



assume the presidency of the G20 from the current Chair Indonesia, Italy and Indonesia, along with India, are part of the G20 troika: past, present and incoming presidencies. The G20 Summit to be hosted next year holds promises of becoming one of the most prolific and high profile international gatherings ever hosted. The Group of 20 or G20 is one of the esoteric forum for international cooperation on the aspects of international economic and financial agenda. It brings together the major developed and developing economies of the world. Collectively, the member nations accounts for about 90 per cent of the global gross domestic product (GDP), 80 per cent of the world's economic output, two-thirds of global population and three-quarters of international trade.

With this backdrop, we would like to usher in and introduce the Engineering 20 (E20) conceptualized by The Institution of Engineers Indonesia (Persatuan Insinyur Indoneisa or "PII") in 2022 while they were hosting the G20. Engineering 20 was initiated as an engagement group of G20 that will, apart from rhetoric and image building exercises, serve as a platform for collaboration to produce tangible and real outcomes. E20 Platform was introduced to work hand in hand to solve our existential challenges facing human kind through meaningful technological collaborations with engineering at the core.

The current serious challenges such as climate change, disruption of production and supply chains, pandemic and wars have devastated the livelihood and survivability of billions of people. Engineers throughout the centuries played crucial roles in sustaining, improving and saving lives. From water sanitation to the production of vitamins, engineers were always on the reckoning. There has been a fundamental lack of leadership quality in engineers in the recent decades. This is the opportune moment for Leader Engineers to come forth to work together in this E20 platform to solve the real issues in the real world.

2022 after a long gap. A Souvenir was released by the President, IEI, the Chief Guest, and the others on the dais, which apart from the abstracts of the papers presented, also included the National Report 2022 compiled and presented by IEI at Oslo in June 2022. The inaugural address was followed by a brief introduction to IMC-fib by Mr Sisir Kumar Banerjee, Past President, IEI & Co-Chairman,IMC-fib. Mr Banerjee spoke at length on the activities of fib, its long association with IEI and the role of IEI towards dissemination of the outcome of the fib Congress among the technical fraternity. While speaking on the occasion, Mr Amitabha Ghoshal, Council Member, IEI &



Member, IMC-fib mentioned that fib organizes the Congress every four years to reflect the advancements in concrete technology over this period and on the transfer of the findings from research to industry practice, by deliberating on the papers presented at the Congress. He mentioned that IMC-fib seizes this opportunity to recall the achievements in the Indian Construction Industry, by compiling the COUNTRY REPORT, containing details of projects that reflect the advancements in technology and construction practices over the past four years. He mentioned that IMC-fib prepared the current National Report on Concrete Structures in India with the active support of a team of high-level experts and the Members of the Civil Engineering Division Board of IEI. The latest report presented during the Oslo Congress held in June 2022, contains 37 such representative projects, highlighting the advancements in the Indian Construction Industry, which is the second-largest consumer of cement in the world. The report has earned wide acceptance and adulation from the Global Community-added Mr Ghoshal.

Dr Akio Kasuga, President, fib, and Dr David Fernandez Ordonez, Secretary General, fib were the Chief Guest and Guest of Honour respectively during the inaugural session of the program and joined the event virtually. Dr Kasuga spoke on fib Model Code 2020 & SAG (Special Activity Group) and explained fib's basic stance on sustainability. He mentioned that Structural concrete accounts for roughly 60% of the cement used in the world. This is responsible for 5% of the annual CO<sub>2</sub> emissions by mankind. The stakeholders involved in fib are the designers, suppliers, builders, and owners. All players are involved in the entire life cycle of a concrete structure. Dr Kasuga spoke on the new Special Activity Group (SAG), which was approved at the Technical Council in Oslo in June 2022, and aims to create a platform within the fib for a database of all CO<sub>2</sub> inventory data related to structural concrete. It was pointed out that manufacturing industries for Cement and reinforcing steel, the main materials used in structural concrete, are investing in research and restructuring to become carbon neutral. However, we as users, cannot wait until they achieve zero-carbon status. Hence, as a transition, we must implement the reduction of CO<sub>2</sub> emissions by using low-carbon technologies. While speaking on fib's endeavors in this direction, he informed that a Task Group has been set up for low-carbon concrete, whose main purpose is to bring together material and structural experts to provide up-to-date information and input to the platform. He also voiced his concern about the lack of data on CO<sub>2</sub> emissions during service for concrete structures and mentioned that fib will gather information on the relationship between durability and CO<sub>a</sub> emissions for lifetime management during the design process. Dr Kasuga brought out that the activities of the SAG are linked to the Model Code 2020, which aims at making structural concrete more sustainable. He concluded by saying that SAG is a long-term project that spans generations, but if we do not take action now, we will eventually be hit with a big payback.

The Guest of Honour, Dr David Fernandez Ordonez, Secretary General, *fib* provided a brief overview of *fib*- its structure, publications of *fib* in the form of The *fib*'s Structural Concrete Journal, provision for Members to view and download *fib* Bulletin; the activities of *fib* like Symposia, Congress and Supported Events, and events of Young Members Group (YMG), and issues related to International Cooperation.

The Inaugural Session was also attended by the Executive Vice President, WFEO and National Member of Executive Council, WFEO, Past Presidents of IEI, President (Elect), Vice President, Council Members, Chairman and Honorary Secretary of West Bengal State Centre, IEI as well as the Secretary & Director General of the Institution. Eminent officials/engineers/professionals/ researchers from abroad/countries having expertise in the field of Structural concrete also joined the program.

The Inaugural Session was followed by three technical sessions.

The Technical Session I was moderated by Mr Alok Bhowmick, Member, IMC-fib & Managing Director, B&S Engineering Consultants Pvt Ltd. Mr U K Rajeshirke, Member, IMC-fib & Managing Director, Spectrum Techno Consultants Pvt Ltd; Mr P Surya Prakash, Council Member, IEI & Member, IMC-fib, and Mr Sandeep Todankar, Principal Consultant (Design), Spectrum Techno Consultants Pvt Ltd presented an overview of the 6<sup>th</sup> fib International Congress 2022, highlighting the salient features. In this session, there was a virtual presentation on the topic 'Construction of Non-metallic Bridge using Zero-Cement Concrete' by Mr Hiroo Shinozaki, and Mr Taku Matsuda, from Sumitomo Mitsui Construction Co, Ltd, Japan.

The Technical Session II was moderated by Mr V N Heggade, Member, IMC-fib. The session included a couple of virtual presentations from Prof Johann Kollegger, Institute of Structural Engineering, TU Wien, Vienna, Austria on the topic 'Fast Erection of Deck Slabs for Steel-Concrete- Composite Bridges and Post-Tensioned Bridges' and Mr Eirik Wie Furunes, Team Leader Long Span Bridges, Norconsult AS, Bergen, Norway on the topic 'Trysfjord Bridge, Parametric Analysis and Modelling for Drawing less Construction of a Concrete Balanced Cantilever Bridge'. This session also included a presentation on the Project: Bridge over Hatania Doania, West Bengal, by Mr Alok Bhowmick and Mr Deepak Singla, Director, S P Singla Constructions Pvt Ltd. Dr Ajay Chourasia, CSIR-Central Building Research Institute, Roorkee, India joined the session virtually and presented his paper published in fib's Structural Concrete Journal, namely, 'Seismic performance assessment of the two-story precast reinforced concrete building.'

The Technical Session III was moderated by Mr M Nagraj, Chairman, Civil Engineering Division Board, IEI & Member, IMC-fib. The highlights of the session included the presentation of two projects from the National Report, namely, 'Nagpur Metro Reach 2 Double Decker Viaduct Project,' presented by Mr Amarsinh B Rautand Mr Sarbajit Roy Choudhury from AFCONS Infrastructure Limited and 'Narendra Modi Stadium, Motera, Gujarat' presented by Mr Eswaran Ramamoorthy, Larsen & Toubro Limited. Dr Satadru Das Adhikary, Assistant Professor, IIT-ISM Dhanbad joined the event virtually and presented his paper on 'Response characterization of highway bridge piers subjected to blast loading' which was published in fib's Structural Concrete Journal. The paper 'A review on performance-based specifications toward concrete durability' was also presented in this session by Dr Bhaskar Sangoju, CSIR Structural Engineering Research Centre(SERC), Chennai, India.

The event received collaboration, sponsorship, and patronage from several reputed organizations, namely Larsen & Toubro Limited,S P Singla Constructions Pvt. ## **Emerging Technologies & Seismic Concerns**

**Indore Local Centre**, IEI organized the 37<sup>th</sup> National Convention of Civil Engineers during 16-17 October 2022 at Imperial Hall, Brilliant Convention Centre, Indore under the aegis of Civil Engineering Division Board [CVDB], IEI. A National Conference was also organized on the occasion on the theme **Emerging Technologies & Seismic Concerns**. Shri Shankar Lalwani, Member of the Parliament, Government of India graced the inaugural function



as the Chief Guest. In his address, Shri Lalwani emphasized on the roles and responsibilities of the engineers to the society and the nation at large. Dr H O Thakare, President, IEI delivered the Presidential Address and mentioned that very aptly the National Convention of Civil Engineers in this year has been planned to deliberate on hazards caused by Seismic Activities with a special focus on the use of technologies in Seismic Design, Seismic Audit and Seismic Retrofitting. Prof (Dr) Ms Shilpa Tripathi, Chairman, Chemical Engineering Division Board and Council Member, IEI briefed the august audience about the details of the technical sessions. During Valedictory Session, Er Narendra Singh, Immediate Past President, IEI graced the function as Chief Guest. ## **ENGINEERING 20 (E20) SUMMIT, Bali, Indonesia 2022**

Indonesia's G20 Presidency has set three priority issues viz. Global Health Architecture; Digital Economy Transformation; and Energy Transition to support global recovery. It was realized that there is a need to establish a sustainable and inclusive development while exploring new avenues to shape a more adaptive G20 against future crisis. Towards this end, The Institution of Engineers Indonesia (Persatuan Insinyur Indonesia-PII) initiated a side event



of G20 Forum known as Engineering 20 (E20). Engineering 20 is proposed as an engagement group of G20 that will serve as a platform for collaboration to produce tangible and real outcomes. E20 Platform is envisaged to work hand in hand to solve our existential challenges facing human kind through meaningful technological collaborations with engineering at the core. E20 will facilitate collaboration for engineers to produce tangible & real outcomes in all areas of engineering including & not limited to green energy transition, digital applications to multiple industrial sectors in workable manners & focusing on efficient & cost effective production of health care products. E 20's agenda is to rapture Engineers from Engineering to Leader Engineers. With series of webinars in online mode in past few months, PII has organized the E20 Summit on 03-04 November, 2022 at Bali, Indonesia.

The Institution of Engineers (India) was officially invited by PII to represent India in E20 Summit. The Institution of Engineers (India) has sent a two member delegation comprising of Dr G Ranganath, Chairman, Committee for Advancement of Technology and Engineering (CATE) & Council Member, IEI and Mr K K Mehrotra, Council Member, IEI in the E20 Summit held at Bali, Indonesia on 03-04 November 2022. The delegation was sent to have a comprehensive understanding of the work at hand as India will be the host

for G20 Summit in 2023 wherein E20 may also be organized as a side event of the Summit.

The Summit started with opening remarks from PII President. Each delegate was then requested to offer their view points on draft communiqué prepared by E20 Secretariat. The delegates were also requested to highlight the contribution made by engineers in their country in the recent past.

The delegation from IEI could uphold the role of Engineers in India during COVID pandemic & also their contribution towards reducing GHG emission. The aspects include Development & installation of small capacity Oxygen generators at hospitals to provide oxygen at affordable cost; Development of Covid Vaccine in short period of time & its distribution in controlled atmosphere to various part of country; Government initiative to increase share of renewal energy like Solar & wind energy; Government initiative to increase electrical and battery operated vehicle to reduce the pollution; Government initiated to increase digital economy through digital transaction; Government initiative to prepare & compile the soil health card at district level to maximize the yield and Development of user friendly software for digital transactions for common people.

This was followed by discussion sessions. During the discussion sessions, it was decided to select few critical areas with tangible action plan to get desired goal. President PII suggested forming interim committee for few critical areas. It was discussed & decided that the chairman of these interim committee will be from Indonesia side being the host of E20. Co chairman will be from different countries. The following interim committees were formed:

1. Renewal Energy 2. Health Care 3. Food security 4. Digital Economy 5. Basic education system 6. Construction—smart material 7. Climate change.

The E20 Summit discussed foundation of E20 that is to formulate standards and criteria for admission into the group of engineers, and to formulate the target objectives by a quantitative approach. Later on, the group contemplates to provide training for engineers to satisfy the minimum requirement for admission on the skill sets of "Ability to learn", deep skills in law, finance, digital and humanity subjects, as well as financial engineering skill and capabilities, and working on real projects.

The E20 platform is envisaged to serve as a platform for the Leader Engineers to act and achieve, recover and sustain together, stronger and in a more pronounced manner.

#### INDEPENDENT AUDITOR'S REPORT

To The Members The Institution of Engineers (India)

#### **Report on the Financial Statements**

#### **Opinion**

We have audited the accompanying financial statements of **The Institution of Engineers (India)** ("the Institution"), which comprise the Balance Sheet as at 31st March, 2022 signed by us under reference to this report and the related Income and Expenditure Account and the Cash Flow Statement for the year then ended, including a summary of the significant accounting policies and other explanatory information (hereinafter referred to as 'financial statements'), in which have been incorporated the returns /accounts received from the various State Centres and Local Centres (also collectively referred to as Centres) of the Institution for the year ended 31st March, 2022 as audited by other auditors and which have been relied upon by us, as mentioned in paragraph 6 of the Note to Accounts (Schedule 13).

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements of the Institution give the information in accordance with the generally accepted accounting principles and the applicable Accounting Standards issued by the Institute of Chartered Accountants of India and read with the Other Matters paragraph below, give a true and fair view of the state of affairs of the Institution as at March 31, 2022 its surplus and its cash flows for the year ended on that date.

#### **Basis for Opinion**

We conducted our audit of the financial statements in accordance with the Standards on Auditing (SA) issued by the Institute of Chartered Accountants of India. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Institution in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India (ICAI) together with the independence requirements that are relevant to our audit of the financial statements and we have fulfilled our other ethical responsibilities in accordance with these requirements and the ICAI's Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion on the financial statements.

#### Management's Responsibility for the Financial Statements

The Management is responsible for the preparation of these financial statements that give a true and fair view of the state of affairs and result of operation of the Institution in accordance with the accounting principles generally accepted in India, including the applicable Accounting Standards. This responsibility also includes maintenance of adequate accounting records for safeguarding the assets of the Institution and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statement that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparation of the financial statements, Going Concern assumption is based on the management's assessment depending on evaluation of the aforesaid matters of the Institution.

The management of the Institution is responsible for overseeing the Institution's financial reporting process.

#### Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee

that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal financial controls relevant to the audit in order to design audit procedures that are appropriate in the circumstances.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Institution's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.
- Obtain sufficient appropriate audit evidence regarding the financial information of the Institution to express an opinion on the financial statements. We are responsible for the direction, supervision and performance of the audit of the financial statements of the Institution of which we are the independent auditors. For the financial statements of the branches incorporated in these financial statements which has been audited by other auditors, such other auditors remain responsible for the direction, supervision and performance of the audit carried out by them. We remain solely responsible for our audit opinion.

Materiality is the magnitude of misstatements in the financial statements that. individually or in aggregate, makes it probable that the economic decisions of a reasonably knowledgeable user of the financial statements may be influenced. We consider quantitative materiality and qualitative factors in (i) planning the scope of our audit work and in evaluating the result of our work; and (ii) to evaluate the effect of any identified misstatements in the financial statements.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

#### **Other Matters**

a) We did not audit the financial statements of 124 centres that are included

in the financial statements of the Institution, whose financial statements reflect total assets of Rs.116,30,71,791/- as at 31st March, 2022 and total revenues of Rs.8,60,65,037/- for the year ended on that date. The financial statements / information of these centres have been audited by the other auditors whose reports have been furnished to us and our opinion, in so far as it relates to the amounts and disclosures included in respect of these centres, is based solely on the report of such centre auditors. Attention is also drawn to the following matters;

- Note 1.10 in Schedule 13 regarding accounting of certain income on cash basis, Note 1.11 in Schedule 13 regarding accounting of certain expense on cash basis, Note 1.13 in Schedule 13 regarding coverage of certain funds by investments and note no.12 of the aforesaid schedule.
- Report of other auditors of the various Centres who have reported, interalia, on certain matters as mentioned in Schedule 12.
- Attention is invited to Note No. 11 in Schedule 13 asserting no fresh admission w.e.f 11.02.2020, pending pronouncement of judgment by Delhi High Court. It may be pointed out herein that adverse pronouncement by Hon'ble Court may prejudicially impact the revenues of the Institution. However the management has taken the necessary steps to reduce its expenditures to match the revenues.

Our opinion is not modified in respect of these matters.

#### Report on Other Legal and Regulatory Requirements

This report does not contain a statement on the matters specified by the Companies (Auditor's Report) Order 2016 ('the Order') issued by the Central Government of India in terms of sub section (11) of section 143 of the Companies Act 2013 as the said Order is not applicable to the Institution.

#### We further report that:

- We have sought and obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purpose of the audit:
- b. In our opinion proper books of accounts as required by law have been kept by the Institution so far as appears from our examination of those
- The Balance Sheet, the Statement of Income and Expenditure and the Cash Flow Statement dealt with in this Report are in agreement with the books of account and with the returns received from the Centres not
- d. The reports on the accounts of the Centres audited by the various Centre auditors have been sent to us and have been properly dealt with by us in preparing this report.
- e. We further report that according to the information and explanation given
  - The Institution has disclosed the impact of pending litigations on its financial position in its financial statements - Refer Note 2 of Schedule 13 to the Financial Statements.
  - ii. The Institution did not have any long-term contracts including derivative contracts for which there may be any material foreseeable losses.
