

and Service Organisations' under the aegis of Production Engineering Division, IEI, during August 18-19, 2017 at Kharagpur. Prof (Dr) N R Bandyopadhyay, Council Member, IEI and Professor, School of Materials Science and

Engineering, IIEST, Shibpur, graced the occasion as the Chief Guest. In his address, Prof Bandyopadhyay mentioned that with the backdrop of irreversible regrouping of materials and processes and changing industrial status, sustainable productivity management in manufacturing and service

organisations are very much relevant. He further highlighted the demand supply gap between the need of qualified professionals in industrial system applications and available resources which affects in solving real life industrial problems. He also mentioned the significance of learning and relearning and advised the engineers to equip themselves with the latest technological developments taking place around the world. Earlier, Mr Shivanand Roy, Immediate Past-Chairman of the Centre, welcomed the august gathering and extolled the effort of the Centre for organizing the technical activities on topical interest. The Workshop was well attended by large number of dignitaries from Danieli Corus, MECON, SAIL, CCL, HEC, BIT, Mesra, Government of Jharkhand, CIT and Fellow Members of the Institution. # IEI Celebrates World Habitat Day

### **Theme: Housing Policies: Affordable Homes**

The World Habitat Day was celebrated by the Institution on October 2, 2017. Brief accounts of celebration as received from various Centres are reported hereunder.

### **STATE CENTRES**

### Gujarat

Mr Dhimant B Vyas, Superintending Engineer & Joint Director, Staff Training College, Gandhinagar, in his welcome address, explained housing policy for affordable homes and



suggested that it is important to delineate the contours of this problem by defining the term 'affordable housing'. The Chief Guest, Mr N K Patel, Director, Sun Builders Pvt. Ltd., Ahmadabad, in his Keynote Address, mentioned that affordable home refers to housing units which are affordable by that section of society, whose income is below the median household income. 'Though different countries have different definitions

for affordable housing, but it is largely the same, i.e. affordable housing should address the housing needs of the lower or middle income households', he opined. Dr S K Patel, Director & Chief Engineer, Staff Training College, Gandhinagar, proposed the vote of thanks.

#### Kerala

Mr P A Prabhakaran, Chief Engineer (Retd.), ISRO and Advisor to Chairman, ISRO, Department of Space, Govt. of India, while delivering the theme lecture, apprised that Central Government aims at providing 50 million homes by 2025 and that the engineers have to bring out results



by completing projects in time keeping in view the cost of labour and cost of materials. He further added that the problem with Low Cost Housing is lack of standards and no uniformity is maintained in construction. Earlier, Mr K S Udaya Kumar, Honorary Secretary of the Centre, welcomed the gathering. Mr N Rajkumar, Chairman of the Centre, proposed the vote of thanks.

### Manipur

Mr N Joykumar Singh, Honorary Secretary of the Centre, welcomed all those present in the function. Mr Kh Angou Singh, Founder Chairman of the Centre, delivered lecture on



the theme mentioning the need of proper utilization of fund. Mr Mangi Singh, Former Deputy Secretary, BOSEM, mentioned the need to take special care of the rare Antlered Deer (Sangai) for its survival which is available only in Manipur. Dr Kiranbala Devi, Department of Civil Engineering, MIT, in her speech, explained that safety of building should be taken as very important

by the engineers in planning, designing and execution. Mr Kh Temba Singh, Chairman of the Centre, focused on the need to take special care on environmental issues for co-existence of all living beings around us. He also spoke about 'Pradhan Mantri Awas Yojana' (PMAY) of the Government of India for construction of houses to the poor and needy persons in the days to come. Mr A Roudrajit Moirang, Joint Honorary Secretary of the Centre, proposed the vote of thanks.

### Telangana

The Chief Guest, Mr S Eshwariah, Chief Engineer, Telangana State Housing Corporation Limited, Hyderabad, in his address, informed that on an average 50% of the urban population lives in slums with congestion having no basic services and 42% of rural population also lives in single room kutcha house. He further explained



that adequate shelter means adequate privacy; adequate space; adequate security including security of tenure; structural stability and durability; adequate lighting, heating and ventilation and adequate basic infrastructure. Earlier, Mr G Rameshwar Rao, Honorary Secretary of the Centre, welcomed the gathering. Dr S Satyanarayana, Chairman of the Centre, presided over the function. Mr S P Anchuri, Joint Honorary Secretary of the Centre, proposed the vote of thanks.

#### **Uttar Pradesh**

Mr V B Singh, Council Member, IEI & Past Chairman of the Centre, welcomed the gathering



and presided over the function. The Keynote Speaker, Prof Subodh Shankar, Dean, College of Architecture and Planning, Integral University, Lucknow, apprised that about 10 crore people all over the world do not have shelter. He further informed that regarding affordable houses, Government of India has initiated construction of low cost houses and has planned to provide houses to all the citizens of the country along with electricity, water and water closet by 2022. Dr Ashok Jain, Ferro

Cement Specialist, presented his proposal for construction of low cost houses between Rs 2.0-4.5 lakh cost, using ferrocement techniques. Mr R K Trivedi, Honorary Secretary of the Centre, proposed the vote of thanks.

### Ahmednagar

He elaborated various factors affecting cost of the houses, such as, type of plot, access of the road; availability of hard strata, power supply, drainage line, labour, material for construction, etc. He suggested that with few modifications in the houses, such as, walls with rat trap

bond, providing more headroom, more windows, provision of bathroom, usage of bamboo in place of steel, etc, it will be more comfortable to house dwellers.

### **Anpara**

The Chief Guest, Mr Akhilesh Kumar Singh, Chief General Manager, ATPS, in his address,

stated that 'Housing Policies: Affordable Homes' is the need of the hour and called upon the engineering community to give equal weightage to the urban and rural population while planning for future projects. The Guest-of-Honour, Mr U C Mishra, Superintending Engineer, ATPS along with Mr Prashant Kumar and Mr Mukesh Kumar Singh, of BHEL, presented a detailed account of various issues related



to the theme. Mr Deepak Kumar, Superintending Engineer and Mr D P Pandey of Anpara Thermal Power Project, also attended the programme. Earlier, Mr Ajai Kumar, Chairman of the Centre, welcomed the august gathering. Mr Dhirendra Kumar Singh, Honorary Secretary of the Centre, proposed the vote of thanks.

parameter as to how much cheaper these (affordable housing) units will be. He further stated that land being a major cost factor and a subject matter of the concerned states, the price margins will vary from state to state. Mr Sudhir Kumar Gupta, Honorary Secretary of the Centre, also addressed the gathering and proposed the vote of thanks.

Mr R K Roy, Chairman of the Centre, in his welcome address, mentioned that affordable

housing is housing which is deemed affordable to those with a median household income as estimated by the national government or a local government by a recognized housing affordability index. Mr M N Bandyopadhyay, Honorary Secretary of the Centre, in his introductory



address, highlighted the significance of the day. The Guest-of-Honour, Dr C Samajdar, Deputy General Manager, Public Relation, SAIL, DSP, gave an overview of present housing challenges in India. The other Guest-of-Honour, Dr D V Rajan, Superintending Engineer, DVC, DSTPS, Andal, stated that one of the key challenges for a developing country like India is urban migration which is further exacerbated by limited resources to meet increasing housing demands. Mr M N Bandyopadhyay, proposed the vote of thanks.

Mr B S More delivered the welcome address. Speaker of the day, Dr Shashikant R

### INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF THE INSTITUTION OF ENGINEERS (INDIA)

### 1. Report on the Financial Statements

We have audited the accompanying financial statements of The Institution of Engineers (India), ("the Institution"), which comprise of the Balance Sheet as at March 31st, 2017, signed by us under reference to this report and the related Income and Expenditure Account and the Cash Flow Statement for the year then ended and a summary of significant accounting policies and other explanatory information, in which have been incorporated the returns/accounts received from the various State Centres and Local Centres of the Institution for the year ended 31st March, 2017 as audited by other auditors and in some cases also for earlier years, and which have been relied upon by us, as mentioned in Note 6.1 and 6.2 in Schedule 13 except as indicated in paragraph 4 below.

### 2. Management's Responsibility for the Financial Statements

Management is responsible for the preparation of these financial statements that give a true and fair view of the financial position, financial performance and cash flows of the Institution in accordance with the applicable Accounting Standards issued by the Institute of Chartered Accountants of India and generally accepted accounting practices. This responsibility also includes maintenance of adequate accounting records and safeguarding the assets of the Institution and for preventing and detecting frauds and other irregularities, selection and application of appropriate accounting policies, making judgements and estimates that are reasonable and prudent, and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

### 3. Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit.

We conducted our audit in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants of India. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal financial control relevant to the Institution's preparation of the financial statements that give a true and fair view in order to design audit procedures that are appropriate in the circumstances. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of the accounting estimates made by the Management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained and the audit evidence obtained by the other centre auditors' in terms of their reports referred to in sub- paragraph (a) of the Other Matters paragraph below, is sufficient and appropriate to provide a basis for our qualified audit opinion on the financial statements.

### 4. Basis of Qualified Opinion

Our opinion is qualified in respect of the following matters and also in respect of observations of other auditors of the various centres upon whose report we have placed reliance:

a) Returns/accounts of four Centres, as mentioned in Note 6.1 of Schedule 13 have not been incorporated in these accounts, as these were either not received within the cut-off date for submission of accounts or were not considered acceptable by the management of the Institution. Consequently, in cases of these Centres, the figures relating to the income and expenditure for the period as mentioned in Note 6.1 and 6.3 of Schedule 13 and the entries relating to the assets and liabilities as at 31st March, 2017, the extent of which in both the cases are not ascertainable at this stage, have not been incorporated in the financial statements of the Institution. It has

- not been possible for us, under the circumstances, to ascertain the extent of the impact of the above on the Institution's results for the year and on its net assets at the year-end.
- b) Income tax has not been deducted at source as per the provision of Chapter XVII of the Income Tax Act, 1961 in respect of Ludhiana Local Centre, the amount of which has not been reported by the Centre auditors.TDS return not filed in case of Bihar State Centre despite TDS being deducted and deposited timely.
- c) Professional tax on payment of salary to employees not deducted for Nasik Local Centre.
- d) Note no 25 of Schedule 12 regarding fund misappropriation at Tiruchirapalli Local Centre.
- e) Note 1.10 in Schedule 13 regarding accounting of certain income on cash basis, Note 1.11 in Schedule 13 regarding accounting of certain expense on cash basis, Note 1.13 in Schedule 13 regarding coverage of certain funds by investment.

### 5. Qualified Opinion

In our opinion and to the best of our information and according to the explanation given to us, except for the possible effects of the matters described in the Basis for Qualified Opinion paragraph whose effect is not quantifiable, the financial statements give the information in the manner so required and give a true and fair view in conformity with the Accounting Standards generally accepted in India;

- 5.1 In the case of the Balance Sheet, of the state of affairs of the Institution as at 31st March, 2017;
- 5.2 In the case of the Income and Expenditure Account, of the surplus for the year ended on that date; and
- 5.3 In the case of the Cash Flow statement, of the cash flows for the year ended on that date.

### 6. Other Matters

- We did not audit the financial statements of 111 centres included in the financial statements of the Institution whose financial statements reflect total assets of Rs. 98,60,00,389/- as at 31st March, 2017 and total revenues of Rs 13,43,14,906/- for the year ended on that date, as considered in the financial statements. The financial statements / information of these centres have been audited by the other auditors whose reports have been furnished to us, and our opinion in so far as it relates to the amounts and disclosures included in respect of these centres, is based solely on the report of such centre auditors. Attention is also drawn to the following matters;
- b) In case of Asansol, Dhandbad, Ghaziabad and Vadodara local Centres and those of, Tamil Nadu, Uttar Pradesh and Bihar State Centres lease deeds have expired. Lease deed of Bhilai Centre expired on 18th February,2003 and the Centre had applied for renewal of the same. Building of Dhanbad Centre has been seized by Zila Parishad.
- Note No 10 of Schedule 13 of the Notes to Accounts regarding non-availability of Income Tax exemption under section 35(1)(ii) of the Income Tax Act.
- Note 11 of Schedule 13 of the notes to accounts regarding review by All India Council for Technical Education (AICTE) of the Section A & B examination of the 15 recognized engineering courses conducted by the Institution and a bar on fresh enrolment with effect from 1st June, 2013 which has been stayed by the Honourable Delhi High Court.
- Report of other auditors of the various Centres who have reported, inter-alia, on certain matters is mentioned in Schedule 12.

Our opinion is not modified in respect of these matters.

### 7. Report on Other Legal and Regulatory Requirements

This report does not contain a statement on the matters specified by the (Auditor's Report) Order 2015 ('the Order') issued by the Central Government of India in terms of sub section (11) of section 143 of the Companies Act 2013 as the said Order is not applicable to the Institution.

### 8. We further report that

Except for the effects of the matters disclosed in the Basis of Qualified Opinion paragraph herein above, we have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purpose of the audit;

- 2. Except for the effects of the matters disclosed in the Basis of Qualified Opinion paragraph herein above, in our opinion proper books of accounts as required by law have been kept by the Institution so far as appears from our examination of those books;
- The Balance Sheet, the Statement of Income and Expenditure, and the Cash Flow Statement dealt with in this Report are in agreement with the books of account and with the returns received from the centres not visited by us.
- 4. Except for the effect of matters described in the Basis of Qualified Opinion paragraph herein above, in our opinion, the aforesaid financial statements comply with the Accounting Standards issued by the Institute of Chartered Accountants of India.
- 5. The reports on the accounts of the centres audited by the centre auditors have been sent to us and have been properly dealt with by us in preparing
- 6. We further report that according to the information and explanation given
  - The Institution has disclosed the impact of pending litigations on its financial position in its financial statements - Refer Note 2 of Schedule 13 to the Financial Statements.

Building of the Centre was sealed by the Dhanbad Zila Parishad based on the order of the Jharkhand High Court. The Centre is contesting the order for reopening of the office building.

A suit has been filed by the Dhanbad Zila Parishad against which liability has not been ascertained.

The account with Allahabad bank has been inoperative for some time. Lease deed expired.

Balances of some advances and security deposits are subject to confirmation/reconciliation from respective parties.

During the year an amount of Rs 700 is written off in the books in respect of obsolete inventory items and shown under miscellaneous expenses.

#### 13. JODHPUR LOCAL CENTRE:

In respect of Jodhpur Local Centre there was a contingent liability amounting to Rs. 843,284/- for land and building tax against which Rs. 72,650 /-had been deposited by the Institution. This land and building case has been settled but no document received from Land and Building Tax Department till date. A letter from land and building tax cell of Small saving directorate dated 08/06/2007 was written to local body to dispose off the case and refund the money to the Institution. After that nothing has been heard from the local body despite being in regular contact with them.

### 14. JAMSHEDPUR LOCAL CENTRE:

Title deed not yet made since lease to TISCO not yet settled by State Government.

### **15. KANPUR LOCAL CENTRE:**

Loans & Advances include Rs.245,000/- by fraudulent encashment of Fixed Deposit Receipts and withdrawal of cash from a savings bank Account during the years 2000-01 and 2001-02 for which litigation is pending. Rs.65,527/- has been written off during the year 2010-11 vide management decision in their meeting dated 20/02/2011.

### **16. KARNATAKA STATE CENTRE:**

Suits are filed against the centre for which the amount is not ascertainable. Fixed asset register is under completion and updation.

Delay in remittance of TDS.

### 17. KERALA STATE CENTRE:

In case of fixed deposits an amount of Rs.20801/- has been noted as difference between maturity amount and reinvested amount which has been shown as TDS on fixed deposit.

A demand of Rs.322,38,652/- has been raised for lease rent against which a case was filed and subsequently a stay order was issued vide no WP© No 18931/2016(N) dated 29th August 2016.

### **18. LUDHIANA LOCAL CENTRE:**

Mr. Hardeep Singh, peon cum chowkidar resigned w.e.f 19/11/2007 but there was a dispute regarding his resignation and arrears. The case is still pending in Court. Further an amount of Rs. 2,000/- is still recoverable from him out of Rs 5,000/- given to him as advance.

Default in compliance of provisions of TDS. The Institute has paid labour charges to building contractor during the year under audit but no TDS deducted u/s 194C.

No proper evidence/supporting vouchers maintained in case of expenditure incurred under the head Examination.

#### 19. MANGALORE LOCAL CENTRE:

The property has been surrendered to the lessor. The new Mangalore Port Trust, the owner of the land has appropriated the value of the building towards the arrears of land rent claimed by NMPT retrospectively from 01/10/1991 to 31/08/2011. The centre has handed over the lease land back to NMPT on 13/08/2010 as per the Charge list dated 13/08/2010 confirmed by the Estate Officer. The centre has moved the Court of law against the demand raised by NMPT by an order under sub section (1) and (2A) of Section 7 of the Public Premises (Eviction of Unauthorised Occupants) Act 1971 dated 06/04/2016 for arrears of rent amounting to Rs.18,94,056/-.

### 20. MYSORE LOCAL CENTRE:

A suit has been filed in High Court by an ex-employee, the quantum for which is not ascertainable.

### 21. NASIK LOCAL CENTRE:

Professional tax on payment of salary to employees not deducted.

During FY 2011-12 Centre has received demand notice from Nasik Municipal Corporation (NMC) in respect of municipal taxes and of others of Rs 298,281/- for last 5 years. As it was not prefixed and not prior intimated the same has been claimed as expenditure and provision of payment made, the part payment in respect of this Rs 100,000/-has been paid in 2014-15 and balance still payable. In 2014-15 also centre has received NMC house rent tax payable of Rs.298,791/- and same also shown as payable to NMC.

In current financial year centre has done continuous follow up with NMC for waiver of NMC Charges which NMC has approved but not issued any letter. Right now centre has Rs.439.409/- balance as advance with NMC.

### 22. PUNE LOCAL CENTRE:

Fixed asset register to be updated to tally amount with general ledger.

### 23. RAJASTHAN STATE CENTRE:

It is required to write off non material balances shown in the Balance Sheet so that the Balance Sheet depicts a much better picture of the state of affairs.

### 24. TAMILNADU STATE CENTRE:

Lease deed expired.

### 25. TIRUCHIRAPALLI LOCAL CENTRE:

In the Balance Sheet for YE 31.03.2017 the capital fund has been increased by Rs. 8,99,183/- with the wording "amount due from Sreekannaiyan" and in the assets side of the balance Sheet the same amount has been mentioned as amount due from Sreekannaiyan.

These entries have been made in the books of the centre consequent to their findings on misappropriation of funds by Sreekannaiyan a clerical staff now working in IEI Hosur Local Centre during the years ended 31/03/2012, 31/03/2013, 31/03/2014.

### **26. UTTAR PRADESH STATE CENTRE:**

In respect of the Uttar Pradesh State Centre liability has not been provided for House and Water Tax dues for FY 1993 to 2017 amounting to Rs.344,802/-and no further response received from Nagar Nigam.

Lease deed was valid till 15/06/2014. Process of renewal is in progress with department.
