Mr M Venkaiah Naidu, Hon'ble Vice President of India, graced the function as the Chief Guest and



inaugurated the Conference. During his inaugural address, the Vice President highlighted that people require assured, uninterrupted and quality power instead of free power. 'Rapid Urbanization and Industrialization would increase energy demand and consumption and to meet this demand, nuclear power finds a solution since it is cost effective and environment friendly', he added. The Chief Guest cited examples of Tarapore and Kundankulam plants which are generating power at 92 paise and Rs. 3/- per unit respectively. Mr Naidu referred

The members welcomed the announcement. Thereupon, Mr Sisir Kumar Banerjee took over charge from Mr Navinchandra B Vasoya and presided over the meeting.

Mr Sisir Kumar Banerjee, President presented the Scroll of Honour to Mr Navinchandra B Vasoya, Immediate Past President.

Mr Sisir Kumar Banerjee thanked the Council and the members present for electing him as the President of The Institution of Engineers (India) and sought their help and guidance for further development of the Institution. He then delivered his Presidential Address.

In his address, the President expressed that he was grateful to the Council for having bestowed upon him the opportunity for serving the Institution in this prestigious position. It would be his endeavour to keep up the high standards set by his eminent and illustrious predecessors.

He underscored the necessity of all round agricultural development with the application of innovations in the domain of Science & Technology and stressed that the development of ground water and surface water resources be looked upon as complementary activities to establish planned irrigation facilities ensuring intensive cultivation programme for meeting effectively the goal of making India self sufficient in the production of food grain for the entire population of the country. He considered it to be the biggest challenge before the engineers to ensure best development with least carbon footprint on the environment, creating environment-friendly, ecologically appropriate, energy saving developmental options - sustainable for the present as well as the emerging generations down the line.

He assured of his constant focus on the members from all disciplines of engineering science and the technical student community in particular who are the strength and source of inspiration. Regular communication with them, organizing more technical activities to ensure their participation and providing them additional benefits aimed at enhancing their professional knowledge would always be his constant effort.

INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF THE INSTITUTION OF ENGINEERS (INDIA)

1. Report on the Financial Statements

We have audited the accompanying financial statements of The Institution of Engineers (India), ("the Institution"), which comprise of the Balance Sheet as at March 31st, 2018, signed by us under reference to this report and the related Income and Expenditure Account and the Cash Flow Statement for the year then ended and a summary of significant accounting policies and other explanatory information, in which have been incorporated the returns/accounts received from the various State Centres and Local Centres (also collectively referred to as Centres) of the Institution for the year ended 31st March, 2018 as audited by other auditors and in some cases also for earlier years, and which have been relied upon by us, as mentioned in Note 6.1 and 6.2 in Schedule 13 except as indicated in paragraph 4 below.

2. Management's Responsibility for the Financial Statements

Management is responsible for the preparation of these financial statements that give a true and fair view of the financial position, financial performance and cash flows of the Institution in accordance with the applicable Accounting Standards issued by the Institute of Chartered Accountants of India and generally accepted accounting practices. This responsibility also includes maintenance of adequate accounting records and safeguarding the assets of the Institution and for preventing and detecting frauds and other irregularities, selection and application of appropriate accounting policies, making judgements and estimates that are reasonable and prudent, and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit

We conducted our audit in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants of India. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal financial control relevant to the Institution's preparation of the financial statements that give a true and fair view in order to design audit procedures that are appropriate in the circumstances. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of the accounting estimates made by the Management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained and the audit evidence obtained by the other centre auditors' in terms of their reports referred to in subparagraph (a) of the Other Matters paragraph below, is sufficient and appropriate to provide a basis for our qualified audit opinion on the financial statements.

Basis of Qualified Opinion

Our opinion is qualified in respect of the following matters and also in respect of observations of other auditors of the various centres upon whose report we have placed reliance:

- TDS not deducted on some contractual payments in case of Jharkhand State Centre, on labour charges to building contractor in case of Ludhiana Local Centre and in some cases for Bathinda Local Centre, the amount of which has not been reported by the Centre auditors. TDS return not filed in case of Bihar State Centre despite TDS being deducted and deposited timely. There is a delay in remittance of TDS in certain cases for Karnataka State Centre and Neyveli Local Centre.
- GST registration not taken in the case of Madhya Pradesh State Centre and Andaman Nicobar State Centre. In case of Assam State Centre and Telengana State Centre GST registration taken by State centres but names of Local Centres not included. In case of the Ghaziabad Local Centre and the Palghat Local Centre names of these centres have not been included as additional place of business under the respective State Centre registration.

- c) GST not collected/deposited regularly in the case of Alwar Local Centre, Dharwad Local Centre, Ghaziabad Local Centre, Jabalpur Local Centre and Bathinda Local Centre
- d) Note no 16 and note no. 30 of Schedule 12 regarding fund misappropriation at Kanpur Local Centre and Tiruchirapalli Local Centre respectively.
- e) Note 1.10 in Schedule 13 regarding accounting of certain income on cash basis, Note 1.11 in Schedule 13 regarding accounting of certain expense on cash basis, Note 1.13 in Schedule 13 regarding coverage of certain funds by investment.

5. Qualified Opinion

In our opinion and to the best of our information and according to the explanation given to us, except for the possible effects of the matters described in the Basis for Qualified Opinion paragraph whose effect is not quantifiable, the financial statements give the information in the manner so required and give a true and fair view in conformity with the Accounting Standards generally accepted in India;

- 5.1 In the case of the Balance Sheet, of the state of affairs of the Institution as at 31st March, 2018;
- 5.2 In the case of the Income and Expenditure Account, of the surplus for the year ended on that date; and
- 5.3 In the case of the Cash Flow statement, of the cash flows for the year ended on that date.

6. Other Matters

- a) We did not audit the financial statements of 121 centres that are included in the financial statements of the Institution, whose financial statements reflect total assets of Rs.105,06,83,615/- as at 31st March, 2018 and total revenues of Rs 16,22,02,279/- for the year ended on that date. The financial statements/ information of these centres have been audited by the other auditors whose reports have been furnished to us, and our opinion in so far as it relates to the amounts and disclosures included in respect of these centres, is based solely on the report of such centre auditors. Attention is also drawn to the following matters:
- b) In case of Dhanbad, Kanpur and Vadodara Local Centres and those of Tamil Nadu and Bihar State Centres lease deeds have expired. Lease deed of Bhillai Centre expired on 18th February,2003 and the Centre had applied for renewal of the same. Building of Dhanbad Centre has been seized by Zila Parishad.
- Note No 10 of Schedule 13 of the Notes to Accounts regarding final rejection by the CBDT of Income Tax exemption under section 35(1)(ii) of the Income Tax Act
- d) Note 11 of Schedule 13 of the notes to accounts regarding review by All India Council for Technical Education (AICTE) of the Section A & B examination of the 15 recognized engineering courses conducted by the Institution and a bar on fresh enrolment with effect from 1st June, 2013 which has been stayed by the Honourable Delhi High Court.
- e) Report of other auditors of the various Centres who have reported, inter-alia, on certain matters as mentioned in Schedule 12.

Our opinion is not modified in respect of these matters.

7. Report on Other Legal and Regulatory Requirements

This report does not contain a statement on the matters specified by the Companies (Auditor's Report) Order 2016 ('the Order') issued by the Central Government of India in terms of sub section (11) of section 143 of the Companies Act 2013 as the said Order is not applicable to the Institution.

8. We further report that,

- Except for the effects of the matters disclosed in the Basis of Qualified
 Opinion paragraph herein above, we have obtained all the information
 and explanations which to the best of our knowledge and belief were
 necessary for the purpose of the audit;
- Except for the effects of the matters disclosed in the Basis of Qualified
 Opinion paragraph herein above, in our opinion proper books of accounts
 as required by law have been kept by the Institution so far as appears
 from our examination of those books;
- The Balance Sheet, the Statement of Income and Expenditure and the Cash Flow Statement dealt with in this Report are in agreement with the books of account and with the returns received from the Centres not visited by us.
- 4. Except for the effect of matters described in the Basis of Qualified Opinion paragraph herein above, in our opinion, the aforesaid financial statements

- comply with the Accounting Standards issued by the Institute of Chartered Accountants of India.
- The reports on the accounts of the Centres audited by the various centre auditors have been sent to us and have been properly dealt with by us in preparing this report.
- 6. We further report that according to the information and explanation given to us:
 - The Institution has disclosed the impact of pending litigations on its financial position in its financial statements – Refer Note 2 of Schedule 13 to the Financial Statements;
 - The Institution did not have any long-term contracts including derivative contracts for which there may be any material foreseeable losses:

1. AGRA LOCAL CENTRE:

Rent agreement on plain paper .Lease deed not executed.

2. ALWAR LOCAL CENTRE:

GST not collected/deposited regularly.

3. ASSAM STATE CENTRE:

Fixed asset register is under updation.

GST registration taken by State centre but names of Local Centres is not included as an additional place of business.

4. AURANGABAD LOCAL CENTRE:

There is a contingent liability in respect of construction of building but the amount has not been ascertained.

5. BHILAI LOCAL CENTRE:

Lease deed expired on 18/02/2003. The lease was taken from SAIL Bhillai. Renewal pending.

No fixed asset register maintained.

6. BIHAR STATE CENTRE:

Application for renewal of lease deed filed with appropriate authority and is in process.

No TDS return filed though TDS deducted and deposited timely.

7. BATHINDA LOCAL CENTRE:

TDS not deducted in some cases.

Not GST compliant.

8. COIMBATORE LOCAL CENTRE:

Balance in savings bank account to be considered for transfer to fixed deposit since it has been lying for a long time.

9. DHANBAD LOCAL CENTRE:

Building of the Centre was sealed by the Dhanbad Zila Parishad based on the order of the Jharkhand High Court. The Centre is contesting the order for reopening of the office building.

A suit has been filed by the Dhanbad Zila Parishad against which liability has not been ascertained.

Lease deed expired.

Fixed deposit includes interest amount and not shown at cost.

10. DHARWAD LOCAL CENTRE:

GST not been collected on Rs. 2701/-.

11. GHAZIABAD LOCAL CENTRE:

Inclusion of name as additional place of business could not be verified under GST registration.

No GST charged/levied on any of the eligible receipts. However, Rs. 9180/- has been remitted to UP State Centre against output GST liability arising on account of some receipts.

12. JABALPUR LOCAL CENTRE:

Fixed asset register is very old and is in torn out condition and a new register is being prepared.

Old advances not yet adjusted or recovered and no provision made for the irrecoverable advances.

In the case instituted by Mr. Kailash Sen before presiding officer Labour Court the Institute has raised preliminary objections but an ex parte order was issued on 11.01.2016. Against this Institute has filed an application on 26.02.2016 for setting aside the order. The order was set aside and case adjourned for further proceedings. Case is under process and amount of liability not yet ascertained.

GST not deducted on receipts from sponsorship/advertisement aggregating Rs.481500/-. GST amount Rs. 70,826/-which is to be deposited.

No GST registration taken by State Centre.

13. JAMSHEDPUR LOCAL CENTRE:

Title deed not yet made since lease to TISCO not yet settled by State Government.

14. JHARKHAND STATE CENTRE.

TDS not deducted on some contractual payments.

15. JODHPUR LOCAL CENTRE:

In respect of Jodhpur Local Centre there was a contingent liability amounting to Rs. 843,284- for land and building tax against which Rs. 72,650/-had been deposited by the Institution.

16. KANPUR LOCAL CENTRE:

Rs. 245,000/- in Other Assets Recoverable represents and relates to embezzlement of Rs.3,21,527/- by way of fraudulent encashment of Fixed Deposit Receipts and withdrawal of cash from a savings bank Account during the years 2000-01 and 2001-02 for which litigation is pending. Out of this Rs.11,000/- recovered. Rs.65,527/- has been written off during the year 2010-11 vide management decision in their meeting dated 20/02/2011.

Lease deed expired on 26/10/2017 and under renewal process.

17. KARNATAKA STATE CENTRE:

Suits are filed against the centre for which the amount is not ascertainable. Delay in remittance of TDS.

18. KERALA STATE CENTRE:

In case of fixed deposits an amount of Rs.25,273.44/- has been noted as difference between maturity amount and reinvested amount . This is included under Cash and Bank Balance as TDS on Fixed deposit. It is recommended that this amount(TDS) should either be refunded to the State Centre or written off.

A demand of Rs.3,22,38,652/- has been raised for lease rent against which a case was filed and subsequently a stay order was issued vide no WP(c)No 18931/2016(N) dated 29th August 2016.

19. KOCHI LOCAL CENTRE:

Rs. 50,770/- for souvenir advertisement charges lying in receivables for a long time.

20. LUDHIANA LOCAL CENTRE:

Mr. Hardeep Singh, peon cum chowkidar resigned w.e.f 19/11/2007 but there was a dispute regarding his resignation and arrears. The case is still pending in Court. Further an amount of Rs. 2,000/- is still recoverable from him out of Rs. 5,000/- given to him as advance.

Default in compliance of provisions of TDS. TDS not deducted on labour charges to building contractors and some payments to catering contractors .

Institute is maintaining a cash balance of Rs.11,945/- as on 31.03.2018 against prescribed limit of Rs.100/-.

Fixed asset register maintained but not as per specified format.

21. MANGALORE LOCAL CENTRE:

The property has been surrendered to the lessor. The new Mangalore Port Trust, the owner of the land has appropriated the value of the building towards

the arrears of land rent claimed by NMPT retrospectively from 01/10/1991 to 31/08/2011. The centre has handed over the lease land back to NMPT on 13/08/2010 as per the Charge list dated 13/08/2010 confirmed by the Estate Officer. The centre has moved the Court of law against the demand raised by NMPT by an order under sub section (1) and (2A) of Section 7 of the Public Premises (Eviction of Unauthorised Occupants) Act 1971 dated 06/04/2016 for arrears of rent amounting to Rs.18,94,056/-., was contended as erroneous by the IEI Mangalore Local Centre and a miscellaneous appeal no. 6/2016 was preferred in the court of IV Additional District and Sessions Judge Dakshina Kannada, Mangalore. The Honourable Court has disposed off the appeal favouring the IEI, Mangalore Local Centre by and order dated 12.02.2018 and the order of the Estate Officer mentioned above has been set aside. The court has opined that the IEI Mangalore Local Centre is at liberty to approach the competent court for the recovery of Rs.9,36,000/- from the New Mangalore Port Trust.

22. MYSORE LOCAL CENTRE:

A suit has been filed in High Court by an ex-employee, the quantum for which is not ascertainable.

23. NASHIK LOCAL CENTRE:

The centre has Rs.4,29,350/- balance as unadjusted advance with Nashik Municipal Corporation.

24. NEYVELI LOCAL CENTRE:

Delay in depositing TDS and filing return.

Non provision of carrying value of "Missing Draft" which is appearing in the accounts as receivable for over 3 years.

25. PALGHAT LOCAL CENTRE:

State centre has taken registration under GST but not added Palghat till date.

26. PUNE LOCAL CENTRE:

Fixed asset register in Tally to be updated to reconcile with general ledger.

27. ROORKEE LOCAL CENTRE:

Advance given to Professor P P Agarwal amounting to Rs.50,000/- on 14.01.2016 is still outstanding.

Savings bank account in PNB has become inoperative and balance of Rs. 124,909/- has been transferred to DEAF account of RBI. Efforts should be made to regularise the account.

28. TAMILNADU STATE CENTRE:

Lease deed has expired.

29. TELENGANA STATE CENTRE:

Names of local centres not included in GST registration and it was informed that local centres have not provided valid proof of address.

The State Centres Committee has decided to withdraw the interest on Fixed Deposits on quarterly basis leaving principal balance as deposit. This is against the practice previously adopted.

30. TIRUCHIRAPPALLI LOCAL CENTRE:

Rs. 8,99,183/- shown in the asset side of the Balance Sheet represents amount recoverable from Mr M Sreekanniyan.

31. TIRUNELVELI LOCAL CENTRE:

Annexure III not attached.

32. UTTAR PRADESH STATE CENTRE:

Following cases against the Institution pending since long are as follows:

- M/s D N Brothers for labour charges since 1976.
- M/S Ramjas Ramdayal for material supply since 1976
