Notice seeking nomination for empanelment of Chartered Engineers

Subject: Panel of Chartered Engineers for inspection/appraisalment of second hand machinery/used capital goods – regarding.

Attention of all concerned is invited to the Board's Circular No 07/2020-Customs dated 05.02.2020 regarding "Valuation of second-hand machinery".

This office intends to draw a fresh panel of Chartered Engineers, duly affiliated to and recognized by the Institute of Engineers (India). The panel shall be valid for a period of three (03) years with the condition that performance will be judged on an annual basis and if found satisfactory, the empanelment may be extended for 2nd year and similarly if found satisfactory in the 2nd year, it may be extended for the 3rd year. Also, if at any time performance is not found satisfactory, the empanelment of the Chartered Engineer can be removed at any point of time. Preference will be given to persons having specialization in the particular branch/field of engineering, based on their work experience.

All the stipulated guidelines as contained in the said Circular dated 05.02.2020 must be followed scrupulously by the Chartered Engineers in the case of valuation of second hand machinery/used capital goods. After inspection/appraisalment of second hand machinery/used capital goods, the Inspection/Appraisalment Report shall be prepared by the Chartered Engineer as per the format provided in Form "B" annexed with Board's Circular No 07/2020-Customs dated 05.02.2020.

Interested individuals/engineering firms may apply in the enclosed proforma. Applications complete in all respect, containing the details of qualification, the applicants must possess qualification for appraisalment/ inspection of second hand machinery and certified as such by the Institute of Chartered Engineers. Affiliation Certificate of the Institute of Engineers (India), work experience, and self-declaration of the applicant that he has never been involved in any case involving the violation of the Customs Act / Exim Policy and also has not been blacklisted by any other agency like Syama Prasad Mookerjee Port etc., should reach the Office of the Principal Commissioner of Customs (Port), Custom House, 15/1, Strand Road, Kolkata-700001 by 31.10.2022 Submission of any wrong information will result in cancellation of candidature/membership and also attract penal provisions under the Customs Act, 1962. The submission of the application by itself does

not bestow any right for selection.

The job being of a professional expertise requires high degree of integrity and fairness. At the same time, the certificate issued by the empanelled engineers will be in the nature of suggestive opinion and shall not be binding on the Department.

All the Trade Associations / Chambers of Commerce/ Members of Regional Advisory Committees and Custom House Broker's Association are requested to publicize the contents of this Notice among their members/ constituents.

The existing empanelled members, if applying afresh, are also required to submit Yearly Self Appraisal Report along with their applications.

Further, the **existing panel of Chartered Engineers as per Public Notice No.22/2019 dated 15.03.2019, excluding Shri Sajal Majumder, shall continue till a fresh panel is notified.**
