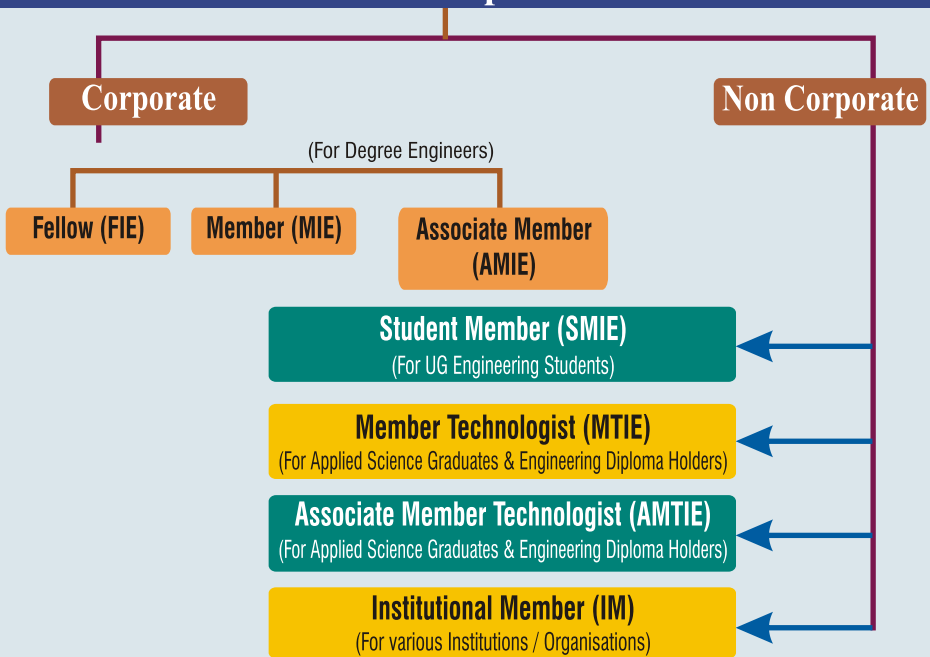

Fees for Opening/Renewal of Students' Chapter at Engineering Colleges/Polytechnics

In a College/University/Institution, at least **fifty numbers (50)** of students irrespective of the year of study in the same branch of engineering is required for opening a Students' Chapter.

To enable formation of Chapter in any recognized polytechnic minimum number of student required is **fifty (50)**. There shall be only one Chapter in Polytechnic.
