Technical Part – Bids (Envelope – 'A') shall comprise of compliance documents Qualification Requirement, IT Return copy, GST certificates, company profile and any other document in support of technical capability. The Technical bid should not contain any financial indication, violation of which will invite disqualification. Financial bid shall comprise of quoted price only in the format provided with the tender document.

Completed Separate tenders against each of the two (Technical part in one envelope, Financial part in another envelope, and the two envelopes put into one third envelope, with all envelopes superscribed about Name of Work and contents, envelope type whether 'A' or 'B') should be submitted to the Receiving Cell of IEI by **09 May 2025**.

All pages of the tender document including tender notice are to be signed by the bidders. IEI reserves the right to reject the tender in full or part without assigning any reason.

SUPPLY OF MERCHANDISED LAPEL PIN

QUALIFICATION REQUIREMENT

- 1. The bidder must be in service of preparation of Merchandised Items since last 5 years.
- 2. The Annual Average Turnover must be Rs.5 lakhs onwards.
- 3. The bidder has to submit the pictures of sample Merchandised Items prepared by them.
- 4. The bidder has to submit the Company Profile.

OTHER TERMS & CONDITIONS

- 1. The mold of Lapel Pin is to be returned back to IEI by the vendor after completion of the job.
- 2. The rates quoted shall be valid for the **period of one year from the date of issuance of work order**. No escalation in price will be entertained during this period.
- 3. Bidders are strictly asked to quote the rate of Merchandised Lapel Pin as specified in the Tender Notice. No rate for any other brand which is not mentioned in the Tender Notice, would be considered.
- 4. The rates/prices quoted shall include packing delivery and all other charges.
- 5. Standard LD Clause for delay in supply / service @ 2% per week or part thereof subject to maximum of 10% of the order value will be applicable.
- 6. IEI reserves the right to reject the tender in part or whole without assigning any reason whatsoever.
- 7. Vendor shall not subcontact the job to any outside agency including their franchisee.
- 8. Payment shall made after successful delivery of items and submission of proforma invoice.
- 9. The initial tenure of the work shall for 12 months which can be extended upon satisfactory performance of the bidder at the existing rate with same terms & conditions. However, decision of IEI shall be final.
- 10. The contract can be terminated by IEI by given 15 days notice in case of unsatisfactory performance.
- 11. **Jurisdiction:** This Agreement will be governed by and constructed in accordance with the laws of India and any dispute arising out of this agreement will be subject to the jurisdiction of Court at Kolkata only.


