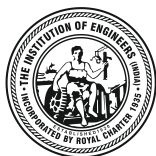

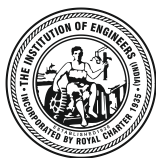

- Applicants are advised to keep the photocopies of the filled in Application Form along with the demand draft and all documents attached therewith for information and future reference.
- Any deficiency/discrepancy in the Application Form is intimated by sending a Letter to the Applicant. Also, the discrepancy with details may be viewed from '**Find Discrepancy**' at our website www.ieindia.org. Every applicant should positively comply his/her discrepancy (if any) within **twelve months. If the discrepancy is not complied within 12 months from the receipt of application, the amount paid by the applicant will be forfeited.**
- In case a candidate is not eligible for election, he/she is eligible for refund of his/her Entrance Fee and the amount deposited for Composite Subscription, without any interest thereon, after deducting non-refundable Registration Fee and General Office Charges as per Regulation. The same is also applicable for applications cancelled because of non-receipt of compliance of discrepancy within the stipulated timeline.
- Every Applicant should carefully note the DD no. and the unique Reference No. received by SMS/IVRS and refer the same for all future correspondence with IEI.
- The decision on every Application rests with the Council of IEI only, which is final and binding on the Applicant.**
