The Technical bid should not contain any financial indication, violation of which will invite disqualification. **Financial Bid** shall comprise of quoted price only in the format provided with the tender document in Envelope – 'B'. Both Envelope – A & B shall be put in a third envelope, sealed and submitted within the prescribed date & time and with signature over it.
